PAYMENT RULES & INTEREST CHARGED:

FEES are payable IN ADVANCE, on or before the 1st day of each month.

INTEREST will be charged on any amount not reflecting in the school account by the 7th day of each month at a rate equal to the prime overdraft-lending rate charged by the Standard Bank of Southern Africa Ltd from time to time.

SUSPENSION DUE TO NON-PAYMENT OF FEES:

Should your account be more than 30 days in arrears, you will be given immediate notice and your child will not be allowed to return to school until the full outstanding payment has been received. Please note that interest will be charged for the late payment of school fees and any unpaid accounts will be handed over for collection at your expense. The Principal reserves the right, at her discretion, to suspend attendance of anyone due to non-payment.

BANKING FEES FOR CASH DEPOSITS:

Clients are liable for all Cash Deposit Fees from the bank incurred as a result of the direct deposit of cash into the Playdayle Account by the client. These banking charges will reflect on the client's following month's invoice issued by the school. Should you wish to avoid being charged any banking fees, please pay all cash directly to one of the teaching staff on duty at the school. Please insist on a receipt for all cash payments made. Alternatively, no charges are incurred for electronic transfers or debit orders.

NON-REFUNDABLE ACCEPTANCE FEE:

Once your child has been accepted, the deposit will not be refunded as a result of any cancellation prior to your child's intended start date. The non-refundable deposit is payable once you have received confirmation of acceptance in writing and will thus guarantee your child's place at Playdayle. This deposit cannot be deducted in lieu of any future or outstanding school fees. The non-refundable deposit is used towards the cost of repairs and maintenance of the grounds and equipment.

NOTICE OF TERMINATION:

One full calendar month's written notice to be given or one calendar month's fees payable in lieu of notice . Notice of Termination may not be given at the end of October, as normal fees for full day and half day will be charged for November and December regardless of attendance due to holidays as school fees are payable over 12 months. Please note that the school fees include 4 weeks of Holiday Care during the academic year at no additional charge, however no discounted rates will be given for non-attendance during the school holidays for any reason.

NOTICE FOR AFTERCARE:

The cost of Aftercare is payable in advance at the beginning of each month. One full calendar months' notice in writing is required should you wish to cancel aftercare for any reason. Failure to comply will result in the client being held liable for the remainder of these costs until the end of the calendar month.
